SORNA Substantial Implementation Review Jicarilla Apache Nation

The U.S. Department of Justice, Office of Justice Programs, Office of Sex Offender Sentencing, Monitoring, Apprehending, Registering, and Tracking (SMART) would like to thank Jicarilla Apache Nation for the extensive work that has gone into its effort to substantially implement Title I of the Adam Walsh Act, the Sex Offender Registration and Notification Act (SORNA). The SMART Office has completed its review of Jicarilla Apache Nation' SORNA substantial implementation packet and has found that Jicarilla Apache Nation has substantially implemented SORNA.

Jicarilla Apache Nation submitted a substantial implementation package on June 14, 2011 and was issued a full review memo on October 31, 2011. The review was re-sent on November 29, 2011. On July 23, 2012, Jicarilla Apache Nation resubmitted a modified code and policies and procedures manual via email along with a memo detailing the Nation's response to the questions posed by the SMART Office. This information included a description of its criminal justice system, courts, and police department; policies and procedures regarding sex offender registration; the Nation's sex offender registration law; and other relevant information. They provided forms and memoranda of agreement with other law enforcement agencies. In addition, email and phone correspondence with the Nation's attorney, Roberta Brito, provided clarification.¹

Our review of these materials follows the outline of the SMART Office Substantial Implementation Checklist-Revised, which contains 14 relevant sections addressing the SORNA requirements. Under each section, we indicate that Jicarilla Apache Nation meets the SORNA requirements of that section.
